Rules & Regulations for children admitted to membership of Club.

The following lays down the Rules & Regulations that govern the conduct of the children admitted as members of the Club and states the responsibilities of the parents or the guardians.

1. It is the responsibility of one of the parents or guardians to bring their child or children, who are enrolled for coaching programmes, to the premises of the Club at the appointed time of coaching / play time and continue to remain within the premises and monitor their child or children during the duration of coaching / play time.
2. It is the responsibility of the parents or guardians to ensure that their children are physically and mentally fit to undertake the coaching programme that they are enrolled into.
3. It is the responsibility of the parents or guardians to ensure that their children behave in a responsible manner while they are within the premises of the Club.
4. The Club, the members of the Managing Committee and the employees of the Club are not responsible for injury caused to any child or a deterioration of the child's health while the child is within or without the premises of the Club or using the Club's facilities, through any sporting activity, accident, incident or any act of nature; it is entirely the responsibility of the parents or the guardians to ensure the well being of the child while within or without the premises of the Club or using the Club's facilities.
5. The Club is not responsible for any act of aggression exhibited or injury caused by one child towards another child and the consequences thereof.
6. Should any property of the Club be damaged by a child, it is the responsibility of the parents or the guardians to ensure that appropriate reimbursements are made to the Club.
7. Should a child behave in an irresponsible manner or be considered unfit by the coach or should any of these rules and/or such other regulations as may be framed by the Club from time to time be violated, the Secretary or a member of the Managing Committee may terminate the membership of the child after due discussions with a parents or guardians of the child.
8. The Club and its facilities shall be used exclusively for the purposes of the enrolled coaching programme or playtime as may be the case and no other.
